Highlights included the Special Districts, County Service Areas(CSA), Landscape Maintenance District Zones (LMDZ), what cost are paid for in the CSA/ LMDZ/ CFD/ PLDO, list of current projects in CSAs/LMDZs, Community Facilities Districts (CFD), Park Land Dedication Ordinance, and a list of current projects in PLDOs.
- Questions by the committee members were answered on how San Dieguito Park is funded, questions on funds for trails, maintenance funds, landscape maintenance process.
