- 4. APPROVAL OF THE MEETING MINUTES

- Crystal Benham, Chief of Resource Management Division gave a presentation on the EIFD. Highlights included and overview of the San Diego River Park (SDRP) vision, Planning efforts, project timeline recap, map including breakdown of districts, trail types, estimated costs, SDRP funding options summary, EIFD overview, EIFD fundamentals, EIFD for San Diego River Park, key dates, timeline overview, public financing authority, and ways to get involved.
