1. Call to order - Vice Chair

- 4. Open agenda --- Opportunity for members of the public to speak on subjects within the Committee's jurisdiction, but not on today's agenda. Limit 2 minutes per item.

Lavonne Norwood – reported on two social media polls regarding the VC Intergenerational Center. 56% of people said Butterfield would be an ideal location. Where does the CSA Board see the location? Bill reminded Lavonne that there is an analysis being done, which includes community feedback and isn't just for the CSA Committee to decide. The Committee's purview is for the current CSA 138 parks. Butterfield is not a CSA 138 facility. It is best that the Priority List is completely filled out, including the Recreational Program priority section under the PLDO priority section.

5. Valley Center Little League – Community Park Improvements

Jordan from VCLL provided an estimate for Diamond Designs to improve the practice field (Field #4). Also has a list of improvement items for fields that include new ADA pathways and nets for foul balls. VCLL also provided a draft letter of maintenance requests. DPR will address asap. VCLL is currently in Fall-Ball season, which ends in mid-November. Regular season begins at the end of February 2025.

6. Park Updates:

VC Community Park- Currently focusing on ballfield maintenance.

Adams Park- Courts 5 and 6 are currently still being resurfaced and are in the final stages. A new park host has moved in. Park rentals have increased post construction. Trunk or Treat will return on October 26th.
